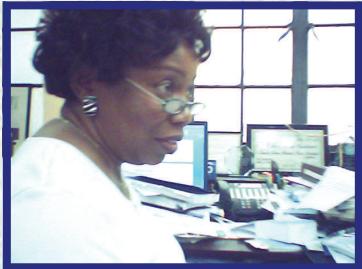

As we come to the close of yet another year we look with anticipation to next year. Ft. George will celebrate 30 years of service to the children and families of Washington Heights in 2011.

President Lyndon B. Johnson 45 years ago signed legislation to fund a comprehensive child development program for low income children and families called Head Start. It is one of the few remaining programs from President's Johnson's "War on Poverty". On the evening of Wednesday September 22, 2010 the National Head Start Association celebrated "The Dream Lives On: Celebrating 45 years of Head Start" in Washington, D.C. One of the honorees was Mr. Patrick Gaspard a former Head Start student from NYC. Mr. Gaspard is a testament that Head Start works and is not generational. He is currently the Director of Political Affairs in President Obama's administration.

If we want the continued support for Head Start from our legislators there must be a paradigm shift in how we operate. As the Director of the Office of Head Start Yvette Sanchez Fuentes stated at the National Head Start Association's Parent Training Conference in Virginia Beach, "That Head Start should not be generational". Ms. Fuentes is really stating that Head Start should help families move from poverty to become economically self sufficient. As an Agency our success is measured by the new families we serve and not by serving families from one generation to the next. So as we begin our registration for the 2011/2012 school year I welcome all the new families that we will be able to serve as they acquire the American dream of self sufficiency.

It certainly has been a rewarding year. As this year comes to a close, I would like to acknowledge and thank the Ft. George Community; the Board of Directors, the DAPC and Staff for providing a quality program to our children and families.

Historical Statement from the Board of Directors

The Ft. George Community Enrichment Center, Inc. was founded and incorporated in 1981 for the purpose of establishing, maintaining, and operating programs in education, employment and training, economic development, housing, health and social welfare. These programs are designed to strengthen the growth and development of individuals and families in the Washington Heights Area.

The organization was formed by community residents who were concerned with the provision of comprehensive services to lower-income families with preschool children, and following them through the early years of elementary school.

The ethnic make-up of the Ft. George Community Enrichment Center's population consists of Hispanic, Black, Asian and Caucasian families. The composition of the Ft. George Community Enrichment Center's Board of Directors reflects this multicultural community with the majority of its members residing within this area.

In line with this, the Washington Heights area is an evolving community of growth. The area is transitional in the sense that there is a relatively high in-and-out migration. Many young families in need of various types of social and health services comprise this neighborhood.

Initially the agency started the operation of our Head Start program with 94 children. As of this year (2010), the program has two sites in the Washington Heights area. Ft. George Community Enrichment Center, Inc. provides quality comprehensive early childhood services to 308 children ages 3-5, and their families .

The first site is located at 1525 St. Nicholas Avenue, and has a licensed capacity for 110 children. at any one time. This site houses the Administration offices of the agency. The second site is located at 601 West 186th Street and has a licensed capacity of 45 children at any one time.

We continue to support the values that we established for ourselves 29 years ago as they have clearly contributed to our ongoing success. On behalf of the Board, I thank the staff and the parents for making 2010 a great year.

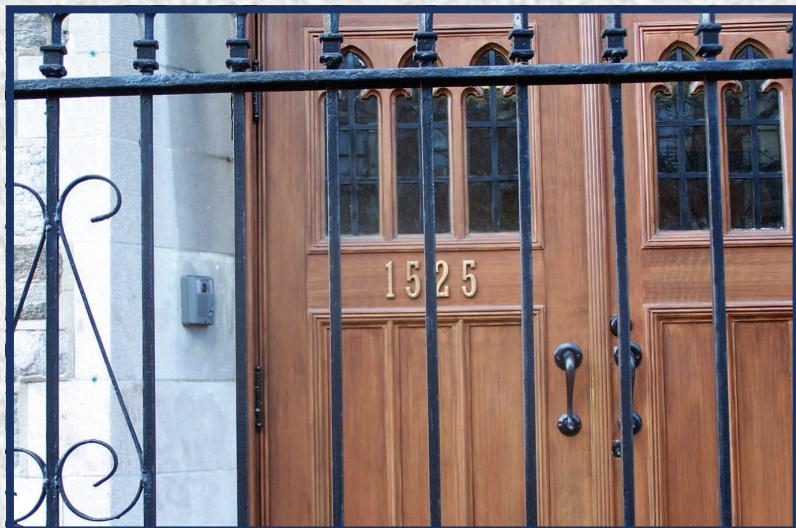

General Highlights 2010

Accomplishments:

- Fort George received a congratulatory letter from ACS stating that we had no findings on the 2009 Federal Review
- Received discretionary funding from Councilman Robert Jackson for a Pre-ESL Program
- Parent recognition was on July 8, 2010 our guest speaker was Ms. Rebecca

Alicea, District 6 Parent Advocate.

- 176 children transitioned from Pre-K to Kindergarten.

The moving on ceremony was on July 23, 2010. The speaker was Mr. Gary King, an early childhood educator, Queens College.

- We were 100% enrolled
- At least 10% of our children were diagnosed with a

disability.

- We continue our partnership with New York Presbyterian Hospital Childhood Asthma Network (WIN for Asthma. As a result of this partnership we have one community health worker.
- The Head Start Audit for PY 45 was unqualified.
- Our partnership with the Mott Hall School Community Service Program continues. We provide our two sites for their middle school students to complete their community service project.

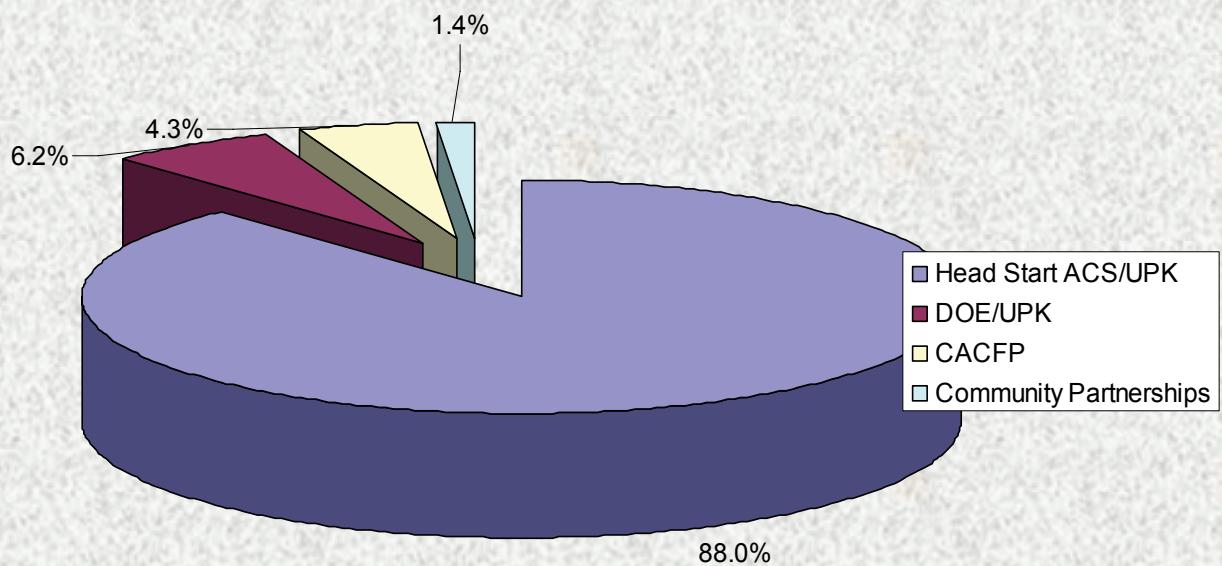
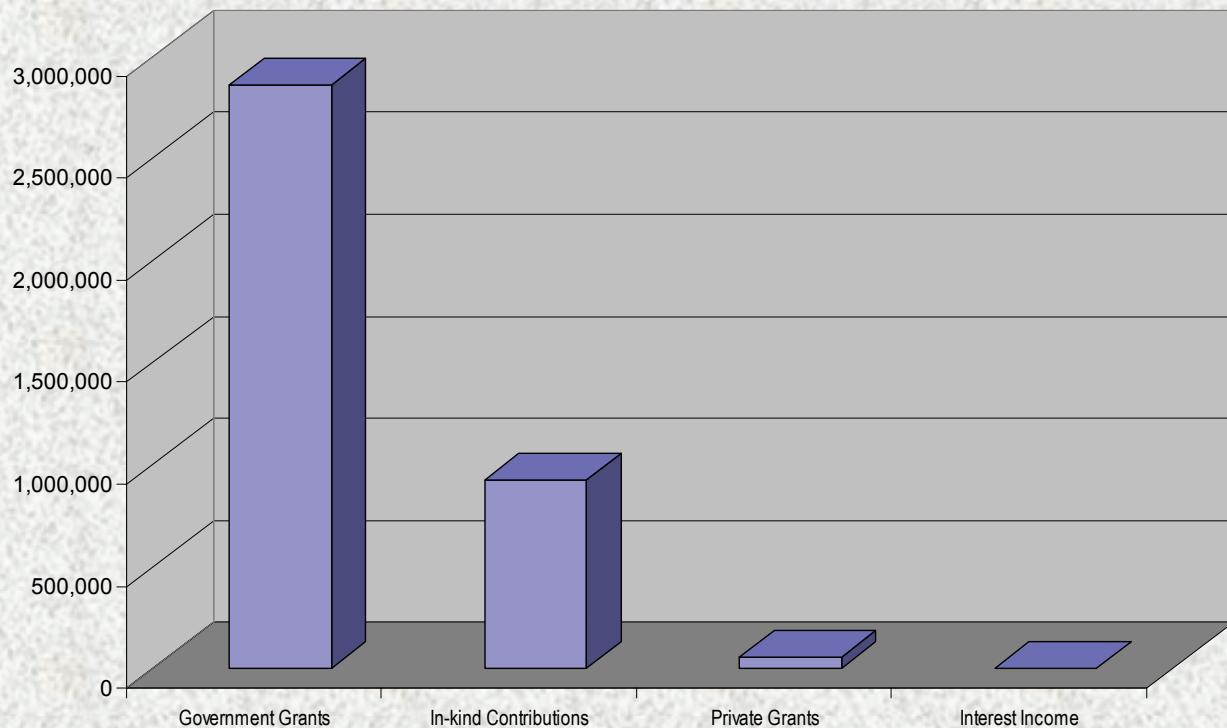
